

**ORDER UNDER SECTION 142 OF THE EXPLOSIVE ACT 1884.**

Whereas it has been made to appear to me that on the occasion of Diwali there is likelihood of fire in the thickly populated Bazaars situated in the Municipal & other town areas of Kaithal District on account of storage, selling and use of fire crackers etc. which can cause tension, annoyances, nuisance or grievous hurt to persons, damage to human life and property, disturbance to public peace and tranquillity within the limits of Kaithal District. And whereas, I am satisfied that immediate measures are needed for the prevention of the disturbance of public peace.

And whereas, considering all these exigencies and after satisfying myself about the likelihood of the breach of peace, I am of the opinion that the sale of crackers/explosive should be banned in the thickly populated bazars of municipal & other town area of kaithal District to prevent danger to public peace and tranquillity or riot of affray.

Now therefore, in exercise of power vested in me by virtue of section 142 of Explosive Act, 1984, I, Sunita Verma, I.A.S., Distt. Magistrate, Kaithal, do hereby prohibit as measure of precaution and maintenance of public peace, the sale of explosives and crackers in Municipal and other town area of Kaithal, Kalayat, Guhla - Cheeka, Pundri, Rajound, Dhand & Siwan except by valid licenses in the areas as mentioned below w.e.f. 14/10/2017 to 21/10/2017.


Each booth will be licensed for possession and sale of fire works not exceeding 50 kg. As per Article 4 (b) of schedule IV of the Explosive Rules, 1983. the inter distance between two booths should be at least 3 meters and the booths should face each other at a distance of minimum 50 feet. Open space should be made available around each booth. The booth should be made of non flammable material. The concerned Tehsildar/Naib Tehsildar, Secretary of the Municipal Council/Committee will ensure the compliance of these directions.

The willing dealers will obtain license for sale of fireworks at District Level, Sub Divisional Magistrate, Kaithal and at sub Division level the concerned S.D.Ms. The sale by these dealers will be restricted to the areas mentioned above w.e.f 14/10/2017 to 21/10/2017. The license holders will strictly comply with the terms & conditions of these orders. These License holders are also directed to ensure strict compliance with the notification no. GSR 6(e) Dated 27-01-1992 regarding ban and import of Chinese fireworks.

Concerned Tehsildar/Naib Tehsildars will inspect all these places of their respective jurisdiction and Sub Divisional Magistrates will be overall incharge in their respective Sub Divisions, Municipal Executive officer /Secretary, Municipal Committee, Kaithal, Pundri, Kalayat, Cheeka, Rajound and Fire Officer, Kaithal will ensure the compliance of this order. In view of the emergent situation and shortage of time, this order is being passed exparte and is being addressed to the public in general.

This order shall be promulgated throughout the Distt. Kaithal by beat of drum, by announcement through the publicity van of Public Relations Department, by fixation of the copies of this order on the notice board of all colleges and schools, Tehsil Office, Municipal Offices, Public Place as well as the police stations.


