

**ORDER UNDER SECTION 144 OF THE CODE OF CRIMINAL PROCEDURE, 1973**

Whereas, it has been made to appear to me by the Mission Director, National Health Mission (NHM), Panchkula, Haryana vide letter No. NHM/Admn./2017/3912-33 dated 12-12-2017 that there is likelihood of causing tension, annoyance, obstruction or injury to person(s), lawfully employed or risk/danger to human life and property, disturbance of public peace and tranquility within the limits of Kaithal District by some agitators, miscreants and antisocial elements on account of striking NHM employees are disrupting the regular discharge of health services by doing Dharna/Protests/Demonstrations in the Govt. Health Facilities.

And whereas, to thwart and prevent occurrence or any possibility of unlawful activities, blocking of roads, passages, disrupting of health facilities etc. by the agitators and assembly of 5 or more persons, carrying of any weapon like fire arms, Sword, Lathi, Barchha, Kulhari, Jellies, Gandases, Knives and other weapon of offence which are likely to cause obstruction in the maintenance of peace and tranquility, it has become necessary to take steps and measures to maintain law and order in District Kaithal in public interest.

Now, therefore, in exercise of the powers vested in me by virtue of Section 144 of Code of Criminal Procedure, 1973, **I, Sunita Verma, I.A.S, District Magistrate, Kaithal** do hereby prohibit gathering of 5 or more persons except at designated places i.e. permitted by the District administration and unlawful activities, blocking of roads, passages, health facilities etc. by the agitators and carrying of any weapon like fire arms, Sword, Lathi, Barchha, Kulhari, Jellies, Gandases, Knives and other weapon of offence which are likely to cause obstruction in the maintenance of peace and tranquility within the 2 KM radius of Government Health Facility area of district Kaithal.


This order shall not apply on police force and public servants on duty for maintenance of law and order, carrying of lathi by handicapped persons and the communities who are entitled to display the weapons by long standing law, custom usage subject to the condition that exemption will lapse if they are found indulging in violence or posing threat to the maintenance of law & order and public order.

This order shall come into force with effect from 13-12-2017 and shall remain enforce till further order.

Any person contravening this order shall be punishable u/s 188 of Indian Penal Code. Superintendent of Police, Kaithal shall implement this order.

In view of requirement of the situation which has become emergent, this order is being passed ex-parte. It shall be published for the information of public through the press and publicity van of Public Relation Deptt. and by affixing copies at notice board of all police stations, MC, Zila Parishad, Panchayat Samiti, Tehsil/Sub Division/District Courts/General Hospital/CHCs/PHCs.
