

ORDER UNDER SECTION 144 OF CODE OF CRIMINAL PROCEDURE, 1973

Whereas it has been brought to my notice by the Addl. Chief Secretary to Govt., Haryana, Home Department, Chandigarh vide Memo No.2/607/2017-IHG dated 13.10.2017. In view of that, it has been made to appear to me that fire crackers are played by the persons to celebrate the festival of Diwali within the limits of Kaithal district. Playing of fire crackers etc. can cause tension, annoyance, nuisance or grievous hurt to persons, damage to human life, disturbance to public peace and tranquility and pollution within the limits of Kaithal district.

Whereas, it has been made to appear to me that there is need to ban the playing of fire crackers during Diwali festival except for the period between 06.30 pm to 09.30 pm on the day of Diwali i.e. 19-10-2017 and I am satisfied that directions are necessary to be issued in this regard.

Now, therefore, in exercise of the powers vested in me under Section 144 of Code of Criminal Procedure, 1973, **I, Sunita Verma, I.A.S District Magistrate, Kaithal** do hereby prohibit the playing of fire crackers during Diwali festival except for the period between 06.30 pm to 09.30 pm on the day of Diwali i.e. on 19-10-2017. The Superintendent of Police, Kaithal shall ensure the compliance by deploying the PCR Vans.

This order shall come into force with immediate effect and shall remain in force till 23-10-2017.

This order shall be promulgated in the district Kaithal by beat of drum, announcement through van of Public Relation Department, by affixing the copy of this order on the notice board of District Courts, Sub Divisional and Tehsil Courts, Municipal Committee Office, Railway Station and other public place as well as in Police Stations.

For the violation of the aforesaid order, if any person is found guilty, he will be liable for punishment under Section, 188 of the Indian Penal Code.
