

**ORDER UNDER SECTION 144 OF CODE OF CRIMINAL PROCEDURE, 1973**

Whereas it has been made to appear to me by Superintendent of Police, Kaithal vide letter no. 26341 dated 27-06-2017 that several incidents of deaths/injuries have been reported in recent past due to celebratory firing during marriage and other functions. As per law, the arms license holders are allowed to keep weapons for security reasons and they cannot resort to firing in celebrating mob endangering the life of other persons.

Whereas, it has been made to appear to me that there is need to ban celebratory firing during marriage and other functions.

Now, therefore, in exercise of the powers vested in me under Section 144 of Code of Criminal Procedure, 1973, **I, Sanjay Joon, I.A.S District Magistrate, Kaithal** do hereby ban celebratory firing during marriage and other functions within the limits of District Kaithal from 29-06-2017 to 28-12-2017. The Superintendent of Police, Kaithal shall ensure the compliance of these orders.

This order shall come into force with immediate effect.

This order shall be promulgated in District Kaithal by beat of drum, announcement through van of Public Relation Department, by affixing copies of this order on the notice boards of District Courts, Sub Divisional and Tehsil Courts, Municipal Committee Offices, Railway Station and other public places as well as in Police Stations.

For the violation of the aforesaid order, the person found guilty will be liable for punishment under Section, 188 of the Indian Penal Code.
