

ORDER UNDER SECTION 144 OF THE CODE OF CRIMINAL PROCEDURE, 1973

Whereas, it has been made to appear to me by Superintendent of Police Kaithal vide letter No-4649/security dated 07-03-2018 that there is likelihood of causing tension, annoyance, obstruction or injury to person, danger to human life and property, disturbance of public peace and tranquility by the Dharna/Mashal Jaloos called by Anganwadi Workers & Helpers at Mini Secretariat Kaithal and surrounding area on 09-03-2018.

Whereas, it has been made to appear to me that anti Social elements may create serious law and order problem in District Kaithal.

And whereas it has been made to appear to me that gathering and movements of five or more persons is likely to cause obstruction in the maintenance of peace and tranquility. Therefore, it has become necessary to prohibit the gathering and movement of five or more persons and persons carrying weapons of offence like fire-arms swords, lathis, barchhas, kulharis, jellies, gandasis, knives and any other thing which can be used as weapon of offence or which is likely to cause obstruction in the maintenance of peace and tranquility during Dharna/Mashal Jaloos called by Anganwadi Workers & Helpers at Mini Secretariat Kaithal and surrounding on 09-03-2018.

And Whereas, I am satisfied that the directions are necessary to avoid injury to persons lawfully employed or risk or danger to human life and property and disturbance of public tranquility, riot and affray.

Now, therefore, in exercise of the powers vested in me under section 144 of Code of Criminal Procedure, 1973, I, Sunita Verma, I.A.S, District Magistrate, Kaithal do hereby prohibit the gathering and movement of five or more persons carrying weapons of offence like fire-arms swords, lathis, barchhas, kulharis, jellies, gandasis, knives and any other thing which can be used as a weapon of offence or which is likely to cause obstruction in the maintenance of peace and tranquility during Dharna called by Anganwadi Workers & Helpers at Mini Secretariat Kaithal and surrounding area on 09-03-2018.

This order shall not apply to the police/Military/Para Military Forces and other public servants on duty.

In view of the emergent situation and shortage of time, this order is being passed ex-parte and is being addressed to the public in general.

This order shall be promulgated within district Kaithal by beat of drum, by announcement through the publicity van of District Information and Public Relations Department, by affixing of copies of this order on notice boards of District Courts, Sub Divisional courts, Tehsil Courts and Public places as well as the police stations.

For the violation of the aforesaid order, if any person is found guilty, he will be liable for punishment under section 188 of the Indian Penal Code.
